- Curriculum & Achievement D.Rufo. <u>C & A Meeting Minutes.</u> Ongoing focus on teachers having support they need to continue remote teaching and track students. Discussion of launch of hybrid learning. Administration feels in good shape to meet health and safety and instructional requirements.

- Strategic Planning Committee Y.Francois. <u>Strategic Planning Committee Minutes.</u> Abbreviated meeting. Is one space available that may be good fit for RA's needs, but given remote situation, recommendation was to hold off and review once virtual & hybrid instruction is no longer mandatory. Trustees should board files regarding planning for upcoming discussions.
- Legislative Committee G.Queen. Met on December 4th. Approved email to representatives that were elected or re-elected with information about budget transparency for RA. Discussed potentially holding "virtual" tour of school for new representatives & senators if in person meetings like those held previously are unable to be held. G.Scott details shifts and changes resulting from November election, including new minority leader based in Philadelphia and potential new opportunities relating to newly elected members and their charter school policies.
- Equality & Equity S.Narahari <u>December E&E 2020-Notes.</u> Meeting held yesterday. Highlights: continued work on facilitating book study, mural project space identified, design being adapted for new space, results of survey.
- General discussion of likely overlap of work and focuses between committees:
 - D.Rufo: Discussion of extending committee's goals out into other Committee's including potentially expanding/updating graduation requirements, inclusion of Committee's focus with respect to strategic planning.
