5. Public Comment

- S.Swazak sent email. Wanted to add concerns to attrition of 5th grade and middle school. Parents are concerned about perceived lack of homework and general chaotic environment. Believes communication needs to be improved and made more concise. Requests inclusion of parents in plans.
- **J.Walker** 5ht grade is in "crisis mode" Remains current of hope that spirit of RA will carry us through. Hope is to open lines of communication between parents, students and school. Concern about support for classroom teachers and disciplining for whole class when few children are not following rules. Questions about disruption in learning, making up learning and "gaps" in 5th grade with regard to leadership opporutinties
- **M.Crenshaw** 5th Grade concerns. Believes select students are bullying other students. Requesting information regarding certain student and policy enforcement regarding behavior infractions.
- **K.Lutz** 5th Grade concerns this year is worse than last year with regard to chaotic environment. Believes Q & A session is best to address concerns.
- **E.Andrews** concerns regarding 5th (block 3) grade science class. Questions about teacher support, ability to deal with discipline issues.
- Unidentified sender Comments regarding importance of contributions by all RA community members and whether each member is part of "the solution" or "the problem". Main concern is teacher attrition, even acknowledging pressures of COVID.
- In person K.Wheeles concerns about RA culture, beyond support and teacher attrition. Feels that we gone through steps but not getting resolution. Ideas more open with discipline process (don't see follow through), Refreshing Mountain for team building; Additional ideas submitted via hard copy.
- **A.Allen** concern is not 5th and 6th grade but reputation that teachers are getting because understaffed and not supported. Appreciate that it takes time to find right fit for culture, not just hiring the first candidate. Average time to hire is 8-14 weeks. Education is 24 weeks. Offering to provide recruiting services for no charge.
- **D.Parkinson** Wondering what happened to culture committee. Concerns about teacher attrition. Feels is big problem and is very concerning.
- **L.Diddio** her children have lost many instructors in past year. Feels need to spend time teaching own kids at home because of substitutes not teaching. Appreciate Ms. Rinker and Ms. Weber who have been supportive.
- **A.Lett** wondering if school would look into other schools to see how they are handling behavior issues.
- **M.Roher** struggled with student who has left RA after teacher went on maternity leave. Seeing concern with teachers leaving now for other student.
- Sara? mostly inaudible "people leave for people issues not money". Concern is that leaders are causing attrition.
- C.Angelini concern as to how to support kids that may be being lost amidst behavior issues.
- **A.Howell** Doesn't feel that people are angry with teachers. Would like increased transparency. Thinks there may be disconnect. Both students not as positive about school anyonre
- **D.Weaver** personal commentary regarding her students decisions regarding ongoing enrollment at RA. Concerned about how RA is collecting student's input on concerns and making sure

- **S.Eckerly** Understands that teachers have had a lot of added pressure from COVID and are exhausted. Believes is "top down" environment. Believes we need to find missing link of where the issues on attrition is.
- Ella K. student. Feels like the consequences that are being given are not sufficient and that all students should not be punished for a few student's actions.
- **H.Ervine** recent incident of bullying as to her child, where she feels bullying wasn't dealt with appropriately. Wants to re-instill privilege of being at RA and to utilize wait list for students that want to be at RA.
