918. TITLE I PARENTAL INVOLVEMENT

1. Purpose

The Board recognizes that parental involvement contributes to the achievement of academic standards by students participating in Title I programs. The Board views the education of students as a cooperative effort among the school, parents/guardians and community.

In compliance with federal law, the district and parents/guardians of students: participating in Title I programs shall jointly develop and agree upon a written parental involvement policy. When developing and implementing this policy, the district shall ensure the policy describes how the district will:

- 1. Involve parents/guardians in the joint development of the district's overall Title I plan and the process of school review and improvement.
- Provide the coordination, technical assistance and other support
 necessary to assist participating schools in planning and implementing
 effective parental involvement activities to improve student academic
 achievement and school permanence.
- 3. Develop activities that promote the school's and parent's/guardians' capacity for strong parental involvement.
- 4. Coordinate and integrate parental involvement strategies with appropriate programs, as provide4 by law.
- 5. Involve parents/guardians in an annual evaluation of the content and effectiveness of the policy in improving the academic quality of schools served under Title I.
- Identify barriers to participation by parents/guardians who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority.

- 7. Use findings of annual evaluations to design strategies for more effective parental involvement.
 - 8. Involve parents/guardians in the activities of schools served under Title I.

The Board shall adopt and distribute the parental involvement policy, which shall be incorporated into the district's Title I plan and shall be evaluated annually, with parental involvement.

The Superintendent or designee shall ensure that the district's Title I parental involvement policy, plan and programs comply with requirements of federal law.

The building principal and/or Title I staff shall provide to parents/guardians of students participating in the Title I programs:

- 1. Explanation of the reasons supporting their child's selection for the program.
- 2. Set of objectives to be addressed.
- 3. Description of the services provided.

The Superintendent or designee shall ensure that information and reports provided to parents/guardians are in an understandable and uniform format and, to the extent practicable, in a language, the parents/guardians can understand.

Anannual meeting of parents/guardians of participating Title I students shall be held to explain the goals and purposes of the Title I program.

Parents/Guardians shall be given the opportunity to participate in the design development, operation and evaluation of the program. Parents/Guardians shall be encouraged to participate in planning activities, to offer suggestions, and to ask questions regarding policies and programs.

In addition to the required annual meeting, additional parents/guardians meetings shall be held at various times of the day and evening. At these meetings, parents/guardians shall be provided:

- I. Information about programs provided under Title I.
- 2. Description and explanation of the curriculum in use, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet.

- 3. Opportunities to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children.
- 4. Opportunities to submit parents/guardians comments about the program to the district level.

If sufficient, Title I funding may be used to facilitate parents/guardians attendance at meetings through payment of transportation and childcare costs.

Opportunities shall be provided for parents/guardians to meet with the classroom teacher and Title I teachers to discuss their child's progress.

Parents/Guardians may be given guidance as to how they can assist at home in the education of their child.
